Hall, an Assistant Professor of Early Childhood Education at Clemson University. Furthermore, Dr. Christine Maxwell, the Director of Program Development at the Buffet Early Childhood Institute at the University of Nebraska, Dr. Patsy Cooper, Associate Professor Queens College, CUNY; co-editor of Journal of Early Childhood Teacher Education, and Dr. M. Elizabeth Graue, Sorenson Professor of Curriculum and Instruction at the University of Wisconsin-Madison so graciously led an invited session on the topic of Pre-K in practice. Their insight and commentary about Pre-K from a systems, teacher education, and practical conception of practice spurred many interesting comments and conversations during and after the session about the patch-work systems of public Pre-k that do and do not exist in the US as well as the varied types of programs implemented across the globe. I am sure this is a topic that will continue to receive much attention in future AERA sessions for ours and many other SIGs/Divisions.

Also, thank you again to the Early Math Collaborative at the Erikson Institute, the Early Childhood Education Program at Indiana University, the Department of Curriculum and Instruction at the University of Wisconsin-Madison, and the Early Childhood Education Program at the University of Wisconsin-Milwaukee for co-sponsoring our reception. They helped ensure we provide a nice array of refreshments to our members, and I hope these acts of co-sponsorship can continue with our future meetings.

Some other good news to come out of meeting was the decision by the Executive Board to petition AERA to allow us to add a Graduate Student Representative to the board who would severe one year term working with the Chair to facilitate SIG business and to add a Mid-Career Award for members who are 10 years post dissertation. The SIG also awarded its first Junior Faculty Research Enhancement Grant to Dr. Ersoy Erdemir from Boğaziçi University in Turkey, and his faculty mentor for the award is Dr. X. Christine Wang, an Associate Professor of Early Childhood Education at the State University of New York at Buffalo.

Unfortunately, not all the news that emerged out of our SIG Business meeting this year was good. Over the past few years, we have been running a deficit in our expenditures by using unused funds to cover our expenses (spending about \$3000 more this year than we took in). Doing so has eliminated our savings, and thus, the Executive Board decided to reduce our funding for our awards until we can build up our savings by running a surplus in our budget. To do this, we pan to reduce the stipends that accompany our awards next year by cutting them in half. The Early Career Award will now be \$250, the Dissertation Award \$250, and Student Travel Awards will be \$250. Additionally, we will suspend the Faculty Research Enhancement Grant until we have a budget surplus of \$5000, and then, the Executive Board will decide how to proceed.

I do want to take time to thank Dr. Martha Lash, an Associate Professor of Early Childhood Education at Kent State University (outgoing Senior Member-at-Large), Dr. Julia Atiles, an Associate Professor of Early Childhood Education at the University of Missouri-Kansas City (outgoing SIG Program Co-Chair), and Dr. Amber Friesen, an Assistant Professor of Early Childhood Special Education at San Francisco State University (outgoing Junior Member-at-Large) for all the work they did for our SIG. Marty has overseen both the election of new members as well as our Early Career Award. Julia put together two programs for our SIG, and Amber has overseen both the Student Travel Grants and the Dissertation Award. Combined, each has done an excellent job of ensuring the business of our SIG is executed in a timely and professional fashion. Furthermore, I want to welcome our new elected Senior-Member at Large, Dr. Debra Ackerman, Early Childhood Researcher at the Early Childhood Research & Assessment Center for Educational Testing Service and our newly elected Junior Member-at-Large, Dr. Lucinda Heimer, an Assistant Professor of Early Childhood Education at the University of Wisconsin-Whitewater. Additionally, Dr. X. Christine Wang will help Dr. Abigail Jewkes with the 2016 program.

Again, our SIG membership is strong at 428 members, which continues to ensure we have multiple sessions to fill on the AERA program, so thank you for your continued support. Moreover, the work each of you is doing on behalf of those working in the fields of early education and child development and the children and families these programs serves is important. Hopefully, there will be continued progress in both fields so that one day access to high-quality services for all children is a given.

Thanks again, and I look forward to seeing all of you in Washington, DC for the AERA centennial.

2015 Early Research Career Award

Anna H. Hall

Assistant Professor of Early Childhood Education, Clemson University

Dr. Anna Hall was chosen for the 2015 Early Education/Child Development (EE/CD) SIG Early Research Career Award to honor a scholar in his/her first five years of earning the doctorate. Dr. Hall has been an assistant professor in the Eugene T. Moore School of Education at the Clemson University, Clemson, South Carolina since 2012. She received her Ph.D. in Early Childhood Education at the University of Kentucky. She is a former kindergarten and primary grade teacher.

Dr. Hall's research focuses on writing and young children. Her research examined the use of interactive writing as a tool for advancing what and how the young writers compose. Dr. hall is a very productive scholar. She has published over 12 peer-reviewed articles in the journals such as Young Children, The Reading Teacher, Journal of Research in Education, Journal of Early Childhood Research. She is also serving as a co-editor of the Literacy Research Association yearbook.

Her recommenders describe her as one of the leading new scholars in the area of early childhood writing instruction. She is currently engaged in research funded by the Gates Foundation in which she is developing writing apps for young children. Congratulations to Dr. Hall who truly deserve this award!

2015 Outstanding Dissertation Award

Erica Barnes

Assistant Professor, University at Albany, State University of New York

We are pleased to announce that Dr. Erica Barnes dissertation research was selected for the 2015 EE/CD SIG Dissertation Award. We had a strong and diverse set of submissions that reflected a commitment and passion to early education and child development. All submissions were reviewed by three independent reviewers. Submissions were scored in the following categories: significance of problem/topic; theoretical framework; method of inquiry/methodology; use of evidence and analysis; depth of analysis and organization of findings; and contribution of the topic to the field of Early Education and Child Development. Reviewers summed their scores, ranked nominees for the award, and then together we discussed the results and came to a consensus.

Dr. Barnes's dissertation is titled, "Head Start Preschool Teachers' Commenting Practices During Shared Book Reading Sessions: Describing Learning Opportunities for Children with Varying Vocabulary Abilities." In this quantitative study, Dr. Barnes investigates the relations between teachers' use of comments during book reading sessions in preschool classrooms and the vocabulary growth of children with low and moderately-low language ability. The findings of her study reveal significant relationships for medium-level comments and children's receptive vocabulary growth and that consideration should be given to both the content and strategy used during instruction. Congratulations again to Dr. Barnes for this outstanding work!

2014 Junior Faculty Research Enhancement Grant

The Junior Faculty Research Enhancement grant was awarded for the first time in 2015. The intent of the award is to use SIG funds (when available) to facilitate research-related activities for faculty who are not yet tenured. We were pleased to have several applicants this year, all of whom are pursuing interesting research directions. The award was given to fund travel for Ersoy Erdemir for collaboration with colleagues. His purposes are

described in his application as "working on my project entitled 'Preschool Students' Engagement with Multimodal Text in the First and Second Language'... Funded by *The Scientific and Technological Research Council of Turkey*, this two-year project investigates the impacts of interactive digital storybook read alouds on 4-to-5-year-old emergent bilingual preschoolers' comprehension skills in their native (Turkish) and second language (English). This is a collaborative and comparative project in that it is the Turkey extension of the project entitled 'Exploring Young Children's Engagement with Multimodal Text', being conducted by Dr. X. Christine Wang and Dr. Tanya Christ in the U.S. Within a two-year time frame, data collected from Turkish and the U.S. sites will be analyzed comparatively in order to identify the multilingual/multicultural dynamics in how young children process digital storybooks presented in a variety of digital features."

2016 Outstanding Dissertation Award Seeking Applications

Annually, the EE/CD SIG awards the Outstanding Dissertation Award for a recent dissertation of exceptional merit. The recipient will receive a plaque from the SIG and a monetary gift at the EE/CD SIG Business meeting. The recipient also receives an automatic invitation to present the dissertation work as part of the EE/CD Business Meeting.

The criteria for this award are:

- 1) A completed and defended dissertation accepted by the Graduate School of the nominee's university within two years of the deadline for submission.
- 2) A study that investigates a topic related to the development of children between birth and age 8, including studies focused on families, teachers and others who care for and educate young children;
- 3) A nominating professor who is a current member of AERA.

Procedures:

To be considered for the award, please submit the following items by e-mail:

- One letter of faculty endorsement from a member of the student's dissertation committee
 who is an AERA member, attesting that the dissertation was completed by the student during
 the time period specified and that the faculty member nominating or endorsing the
 nomination served on the dissertation committee. Please also include the oral defense date.
 This letter should include a brief clarification of the purposes, scope, and quality of the
 student's dissertation research, as well as an explanation of how the dissertation contributes
 to the field of early childhood, child development, or early education.
- Title page for the dissertation (including university/college, name of the professor chairing the dissertation committee and a complete list of committee members). In addition, please add to the title page complete contact information (postal and e-mail) of either the student or the nominator that can be used for all correspondence regarding the award.
- Table of Contents from the dissertation.
- Journal-length manuscript summarizing the study derived from the dissertation and written by the nominee. This manuscript should adhere to the APA manual's (5th ed.) guidelines for manuscript preparation, should be approximately 25-30 pages (double-spaced), and should be geared toward publication. The summary should include: objectives/purpose; perspectives/theoretical framework; methods/mode of inquiry; data sources and analyses; results/discussion; and conclusion and educational/scientific importance of study. The summary should advance the scholarly publication potential of the research and will be judged primarily by a panel of scholars in the field and former dissertation winners.
- 1-2 page summary (abstract) of the study to be published in the SIG newsletter should the award be given to the recipient.

2016 Early Research Career Award Seeking Applications



We are currently seeking applications for the EE/CD SIG Early Research Career Award. The Early Education/Child Development (EE/CD) SIG of the American Educational Research Association (AERA) annually presents the EE/CD SIG Early Research Career Award. This award is made to an individual with a promising record as a researcher and scholar in the early childhood field, as evidenced through an emerging record of a research agenda, publications, and other scholarly activity.

Candidates for the EE/CD Early Research Career Award are within the first five years of having received their doctoral degree. Recipients of this award receive a monetary award in the amount of \$500 and are invited to present a brief synopsis of their research at the SIG business meeting. Nominations for this award may come from members of the EE/CD SIG. Complete nominations will include the following in ELECTRONIC format (e.g., PDF files):

- 1) A letter from the nominator with specific information justifying the nomination, as well as the current employment status of the nominee;
- A second letter of support for the nomination from anyone in the field of early childhood/child development who can speak to the merits and relevance of the nominee's scholarly activity;
- 3) Recent curriculum vitae with complete bibliographic information on the nominee; and
- 4) Copies of 2 publications representative of the nominee's scholarly contributions to the early childhood/child development field.

If the nominator was the dissertation chair or otherwise closely involved with the candidate's doctoral studies, the second letter of support should come from someone who was not involved in the nominee's doctoral degree program. The second letter does NOT have to come from a SIG member, but must be someone in the field of child development and early childhood education.
