# Message from the Chair Nancy File, Univ. of Wisconsin-Milwaukee

Dear SIG members,

I've never been a person who gives a lot of thought to a five- or ten-year plan in life. My reaction to those exercises is that I most often would have been wrong about where I've ended up as I respond to what life brings and how I feel about what I'm doing. Luckily, my term as chair of the EE/CD SIG is only two years; I find that amount of time easier to forecast and plan in some way that feels realistic. But I still feel a mix of thoughts about the time to come – as a SIG, we have already charted some ideas for moving forward, and I know there will be things that we don't anticipate that present new opportunities.

I also know how quickly this time will pass. Living in the summer always reminds me of the grand plans with which I begin and the reality of how soon fall semester actually rolls around. But it is with that sense of excitement for a new time that I consider what might happen over the next two years for the EE/CD SIG.

Once we have approval for these positions in our by-laws we will announce the opportunity for nominations.



### 2016 Distinguished Career Award

It was my sincere privilege to present Lilian Katz, Emeritus Professor of Elementary and Early Childhood Education at University of Illinois, Champaign-Urbana, with the Distinguished Career Award for Contributions to the Field at the annual meeting held in D.C. Lilian was born and raised in England, came to the US at age 15, became a US citizen in 1953, and received her Ph.D. from Stanford in 1968. Lilian's work has focused on research, theory, and practice related to the education and well-being of young children in programs, schools, communities, and at home. A few of her noteworthy accomplishments include that she was:

- Editor of the first, online peer-reviewed, bilingual early childhood education journal, *Early Childhood Research & Practice*:
- Founding editor of Early Childhood Research Quarterly and its editor in chief for 6 years;
- Co-Director of the ERIC Clearinghouse for Elementary and Early Childhood Education for 30 years;
- President of NAEYC and 1st president of the Illinois AEYC; and
- Author of a monthly column for parents of preschoolers for Parents' Magazine for 13 years; and
- Author of well over 100 articles, chapters, and books including her collection of essays,
   *Talks with Teachers*, and as a result of traveling 14 times to study at Reggio Emilia, her
   popular books *Engaging Children's Minds: The Project Approach*, co-authored by Sylvia
   Chard, and *Young Investigators: The Project Approach in the Early Years* co-authored by
   Judy Helms.

Lilian noted that what really matters to her in life is not her numerous accomplishments and awards, but her family, including the three children she raised with her late husband Boris, and the 5 grandsons and her 1 granddaughter whom she cherishes. Kudos to Lilian Katz!

My personal thanks to past-chairs of our SIG who served with me on the nomination and selection committee for this award, including: Andy Stremmel, Stuart Reifel, Nancy Barbour, and Beth Graue. In addition, thank you Kathy Sylva and Jean Mendoza for writing beautiful letters nominating Lilian.

### 2016 Outstanding Dissertation Award

# Dr. Kristin Whyte University of Wisconsin-Madison

The Dissertation Award Committee is pleased to announce that Kristin Whyte's dissertation research was selected for the 2016 EE/CD SIG Dissertation Award. The nominations were impressive and illustrate the depth and breadth of new research in the field of early childhood education. All submissions were reviewed by four independent reviewers. Submissions were scored in the following categories: significance of problem/topic; theoretical framework; method of inquiry/methodology; use of evidence and analysis; depth of analysis and organization of findings; and contribution of the topic to the field of Early Education and Child Development. Reviewers summed their scores, ranked nominees for the award, and the winner was determined based on scores and rankings. The Dissertation Awards Committee would also like to acknowledge the hard work and mentoring of all the advisors of the submitted dissertations as their influence was key. We were inspired by the rigor and creativity exhibited by all the nominees.

One dissertation clearly stood out as unique. Kristin Whyte, advised by Dr. Beth Graue at the University of Wisconsin-Madison, presents the story of Princess, a Head Start teacher. This narrative offers insight about how power, stereotypes, and perceptions of families relate to ideas about home-school relationships. Focusing on the narrative of Princess, Dr. Whyte asks educators to consider who is responsible for creating chaotic images of families' lives and what impact these stories have when they are the ones told about families who live in poverty.

As stated in the nominating letter, "From design to the implications, the quality of Kristin's research is rigorous, intellectually rich, and theoretically nuanced...She struggled, in a good way, with the challenge of how to write the case of a passionate professional whose view she did not always agree with. This is one of the great strengths of this study – her respectful but critical depiction of Princess' relationships with families."

It was an honor to work with dedicated committee members reviewing the stellar work of the nominees. I'd like to thank Sara Michael-Luna, Anne Douglass and Leanne Evans for their thoughtful sharing and feedback in the process.

Congratulations, Dr. Whyte, on this award!

# 2017 Outstanding Dissertation Award Seeking Applications

Annually, the EE/CD SIG awards the Outstanding Dissertation Award for a recent dissertation of exceptional merit. The recipient will receive a plaque from the SIG and a monetary gift at the EE/CD SIG Business meeting. The recipient also receives an automatic invitation to present the dissertation work as part of the EE/CD Business Meeting.

The criteria for this award are:

- 1) A completed and defended dissertation accepted by the Graduate School of the nominee's university within two years of the deadline for submission.
- 2) A study that investigates a topic related to the development of children between birth and age 8, including studies focused on families, teachers and others who care for and educate young children;
- 3) A nominating professor who is a current member of AERA.

#### **Procedures:**

To be considered for the award, please submit the following items by e-mail:

- One letter of faculty endorsement from a member of the student's dissertation committee
  who is an AERA member, attesting that the dissertation was completed by the student during
  the time period specified and that the faculty member nominating or endorsing the
  nomination served on the dissertation committee. Please also include the oral defense date.
  This letter should include a brief clarification of the purposes, scope, and quality of the
  student's dissertation research, as well as an explanation of how the dissertation contributes
  to the field of early childhood, child development, or early education.
- Title page for the dissertation (including university/college, name of the professor chairing the dissertation committee and a complete list of committee members). In addition, please add to the title page complete contact information (postal and e-mail) of either the student or the nominator that can be used for all correspondence regarding the award.
- Table of Contents from the dissertation.
- Journal-length manuscript summarizing the study derived from the dissertation and written by the nominee. This manuscript should adhere to the APA manual's (5<sup>th</sup> ed.) guidelines for manuscript preparation, should be approximately 25-30 pages (double-spaced), and should be geared toward publication. The summary should include: objectives/purpose; perspectives/theoretical framework; methods/mode of inquiry; data sources and analyses; results/discussion; and conclusion and educational/scientific importance of study. The summary should advance the scholarly publication potential of the research and will be judged primarily by a panel of scholars in the field and former dissertation winners.
- 1-2 page summary (abstract) of the study to be published in the SIG newsletter should the award be given to the recipient.

# 2017 Early Career Award Seeking Applications

The Early Education/Child Development (EE/CD) SIG of the American Educational Research Association (AERA) annually presents the EE/CD Early Research Career Award. We are currently seeking nominations for 2017. This award is made annually to the an individual with a promising record as a researcher and scholar in the early childhood field, as evidenced through competitive publications and other scholarly activity suggesting a vital research agenda. Recipients of this award receive a \$500 monetary prize and are invited to present a brief synopsis of their research and interests at the SIG business meeting

Viable candidates for the EE/CD Early Research Career Award are no more than 10 years out from receiving their doctorate and have not received tenure. Nominators must be members of the EE/CD SIG. Nominees who did not receive the award in the initial round will automatically be placed in the following year's pool, even if the 10-year mark has passed. Updated information on the scholar's activity will also be considered in the second round.

Complete nominations will include the following in electronic, PDF format:

- 1) A letter of nomination from a member of the EC/CD SIG, with sufficient justification of nominee's qualifications.
- 2) A letter of support from a second scholar in the field, who can speak to the nominee's qualifications as well. The second letter does not have to come from a member of the EC/CD SIG.
- 3) A copy of the nominee's most recent Curriculum Vitae, including complete bibliographic information and present employment status.
- 4) Copies of 2 or more publications representative of the nominee's scholarly contributions to the early childhood/child development field thus far.

Please note that if the nominator was the nominee's dissertation chair or otherwise closely connected to the nominee's doctoral studies, the second letter of support should come from someone outside the doctoral degree program.

### **Budget Summary for Current Year 2016**

Below is the estimated budget for this year, based on the current member count of 434.

- 1. Our member count as of 4.8.2016 is 434 which is more than our member count of 428 in April 2015. HOORAY! We are able to reverse the trend of decreasing membership!
- 2. By using the cost saving measures and not giving out awards to Early Career and Junior Faculty Research, our awards cost is much lower.
- 3. For the first time in several years, we will have a surplus of about \$1200 this year, bringing our remaining balance to around \$7,300.
- 4. This is assuming we did not get any co-sponsorship. If we did, the remaining balance will be higher.
- 5. By being cost sensitive, we've created more funds that can be used to support EECD mission for the coming year. HOORAY!
